




### Who are we?

Our project affects all aspects of life of a modern man who is into the habit of using gadgets, making online purchases and using all accessible modern means of communication to personal advantage.

Our project is an operating business with the annual yield of about 50%. In plain terms, our activity consists of the following stages:

- at the exchanges and within the Internet, we look for the web sites that bring advertising revenue;
- we analyze their financials and technical side;
- the web sites that get through our selection are purchased by us so that the yield is equal to 50%. Exactly from these revenues we are ready to pay one half to our clients. Advertising revenues are generated on a monthly basis that is why we also pay our clients monthly dividends.





## How are the web sites selected and according to which criteria?

First of all, we look out for the web sites that have been active over a year, with positive dynamics of the advertising revenue, with transparent income data (it is desirable that the income is received from big networks, such as Yandex NV or Google Inc).

Subsequently, we pay close attention to the recoupment of these products: if it constitutes two years or less, then such web site is not interesting for us because the yield in that case is about 50% a year.

And thirdly, we study the technical input of the web site and possibilities of its efficient low-cost improvement (this allows us to increase return on capital to 70% a year and higher), then we will definitely buy such a product.







## Legal and technical sides of the BIT TOKEN

Our company works with our own capital and attracts additional capital in order to scale up the business.

Particularly for this purpose, there is an opportunity to make investments via personal cabinet by entering into the investment agreement which gives the right for the receipt of dividends. ### The market

Our market is the market of web advertising, monetization of web traffic. It is extremely global and constitutes about 250 billion c.u. as of today. While the entire aggregate volume is equal to 1.5 trillion c.u.

This market is mainly controlled by a few big players which we receive revenue from.


The market increases by 10–15 billion c.u. a year replacing the former mechanisms of advertising.



### **Business model**

We buy web sites and applications that pay off in 2 years. This means the revenue-generating capacity is about 50% p.a. We give to our clients half of the returns leaving the other half to ourselves - to improve and maintain our websites as well as acquire new ones. We modernize the acquired web sites and applications on a regular basis attracting additional traffic, increasing advertising revenue in order to receive 70% p.a. and higher. In the majority of cases, we purchase the web sites through the exchanges. In that kind of transactions, the exchange acts as a guarantee for the two parties: the seller and the buyer. It looks fairly simple: we confirm the position for the purchase of the web site, the exchange freezes the funds equal to the cost of the web site and at that time the seller contacts us and starts to provide the access to the web site (most important of all – the domain). After the data connection is completed, both parties notify the exchange of this — and it finalizes the transaction. The acquired web site is officially ours.

Payments to clients take place every month for the previous month. This is because the market giants like Google and Yandex make transfers on a monthly basis.










The beginning of the dividend payment takes place after the 30th day from the moment of crediting of the funds to the clients' accounts or the company wallets.

All data about the projects, yield and many other things are visible in our personal cabinet which can be found in our website.

In the future, our company will enter the market of the game development and development on the whole offering franchise for the sales offices in different regions of the world.

Apart from that, we are planning to launch our domain registrar and hosting in which we will integrate all newest blockchain technologies. The next stage will be the exchange service. Any investment is supported by assets, i.e. the web sites that bring advertising revenue.







### Experience and team





We have been working in this area since 2008, in this time we have acquired knowledge and experience in our field. To take the business to the next level, we have created Barin.io service. Our team consists of highly professional people (11 employees on a full-time basis and 23 freelancers).



We have an independent business both in advertising and informational online markets and in IT-development. The geography of our activity applies to Europe, USA and Canada.






Over the course of our activity, we have implemented over 200 small and 9 large projects.



### Difference from competitors



We operate in a global market that grows by 10-15% in a year, and today the aggregate volume of IT-services according to different estimates constitutes to 0.5 trillion - 1.5 trillion c. u.

Our market is a high-margin market therefore we make payments to our clients in the amount of 20-25% p.a.

Understanding that we can earn only by allowing the other to earn we act on the basis of this premise. We value the users of our service, our clients and always try to meet expectations in actual practice.

Our service is convenient and informational as it allows the user to see the balance in online mode in different currencies (euro, dollar, rouble); to replenish and withdraw the funds quickly in currencies and cryptocurrency.




5 Our IT team has a 10-year experience of work in finances, and 20-year experience of work in sales and services, we can always attract the required expert quickly and efficiently.

In our market, there are enough competitors, both big and small, the latter because of the absence of finances and shortage of the core compentencies cannot be our decent competitors, while the former presently are not as feature-rich as ourselves.

Our contractors are mainly the world business giants: Google, Yandex — presently the most financially reliable companies.

Furthermore, we have huge networking all over the world and we can quickly create even an entire department and implement the required technology.

Our service is transparent and easy-to-understand for the clients. Each client and user can see in his personal cabinet the actual flow of the company revenues from known contractors, see the marginality; all financial receipts are also confirmed by the valid and binding documents. # Payment of the advertising revenue

The company has a complete right to increase the share of profit payable to the buyer. Payments are made monthly until the 31st date of the next month for the accounting month. All obligations related to taxation of the profit gained by the company and the buyer shall be performed by the parties according to the applicable tax legislation.



The investor owns 25% p.a. of the amounts spent on acquisition of the share of ownership of the product.





### **BIT token**

The BIT token is a derivative financial instrument which serves as a chargeable unit and authentification means to confirm participation of the token owner in the Barin project.






### Technical implementation of the issuance of tokens in the public blockchain network Ethereum.

The Company Barin (OU "BARA High Tech Est"): issues 50,000,000 BIT (Barin Invest token) tokens at a time. The emission is unalterable, and the smart contract technically restricts the possibility of an additional emission. The token is issued on the Ethereum blockchain-platform in the main network. The token complies with the standard ERC-20 therefore the issued Token is fully compatible with the platform protocol and complies with the requirements of the exchanges.

Any token holder can freely use it to personal advantage: hold it, sell it at the exchange or buy, also the holder can sell the token to third parties at any time on his own or through the exchange.

### About tokenomics

The BIT token has already been listed at the exchanges (trade pair barin/btc), p2pb2b (trade pair bit/btc), sec. markets (trade pair barin/btc).

The funds attracted from cryptocurrency investors (BTC) by sale of the BIT token are used for the purchase of Internet resources. Revenue from the assets is used for the buyback of the token at the exchanges.

Automated system, directly through API Adsence and Yandex Advertising Network, ensures daily automated buybacks at the exchange, exactly for the amount the projects earn on advertising.

Permanent buy-out of the coin at the cost of the advertising revenue is driving up the cost of the coin, due to which the investor earns by selling the coin higher than he/she had bought it. As the advertising revenue is in USD and EUR, the BIT token is not strictly pegged to volatility at the market of cryptocurrencies associated with the change of the Bitcoin exchange rate.

The project team places one sales order for exactly the number of coins that it can use based on the situation in the market of assets (web site exchange), i.e. permanent analytics of the existing offers on the web site sale allows to evaluate how much money can be taken from the investors at the present moment.

The advantage of our tokenomics is as follows: cryptocurrency investors invest their funds into the assets of classic currencies, a nd the income from the assets in dollars and euro is used for the support of cryptocurrency asset (BIT token).



### The use of the blockchain technology

In the future, our team is planning to create maximum robust infrastructure for the BIT tokens. In order to prevent any sensitivity and dependence on the third parties, whether it is a web site exchange, domain registrar, webmaster (manager) exchange or a hosting service, it is necessary to create own services that work on the blockchain with our smart contracts and oracles.

Our own stock exchange is necessary so that all web site transactions are carried via our smart contracts and thereby the BIT token on technological level is to the maximum tied with the blockchain system. Our own domain registrar is needed so that the smart contract can see the tangibility of existence and the fact of domain ownership. Hosting is necessary for verification of the access rights to the web site, reconfirmation of barin.io rights for each purchased/created project. Our own webmaster exchange is needed for the search of the project managers, the BIT holders deduct percentage of income for the management of the projects (assets).


With the help of the newest technologies, we will implement new methods of communication that secure highest confidentiality of a man's private life.

The objective of all this is to secure highest transparency and reliability of the BIT token, make it confirmed with the purchased project, Internet-asset, excluding the possibility of falsifying the fact of existence of the asset and the rights thereto.

Our infrastructure will allow huge numbers of people to use such service safely, earn on it and share their information only with the existence of desire.

Thus, our BIT token will be a form of ownership of a part of the entire infrastructure securing business processes at a completely new technological level and providing service to huge numbers of people.
