



VISION:

Ghostface is a deflationary, fully audited BEP-20 token built on the Binance Smart Chain Network. Ghostface ICO will be launched on May 30th 2021. Three (3) functions occur during each transaction: \$GHOSTFACE Redistribution, Auto Liquidity Pool Acquisition, and \$BNB Redistribution.

Ghostface is completely decentralized and all decisions are made by a community poll. Which gives our developers a better idea of how to move forward with Ghostface. Ghostface is an ICO launched token, and the developer team has no team tokens. In other words, our team has to participate in the \$GHOSTFACE presale along with other investors.



ABSTRACT:

Ghostface was created with the sole purpose of investor's being able to collect \$BNB whilst holding the token '\$GHOSTFACE'. This is a fairly new concept and not readily available in the market or in other tokens. Ghostface will be much more than another MEME project. In-fact we intend to be one of the first meme token with actual value and being that utility token.

Ghostface is an BEP20 token launched on the Binance Smart Chain Network on May 22nd 2021 The max supply of is 1 quadrillion \$GHOST.

☒ **4% Auto Liquidity Pool**

Every trade contributes towards automatically generating liquidity that goes into the PancakeSwap Pool.

☒ **4% Redistribution into \$BNB**

4% of every transaction is taken and redistributed to all Ghostface holders directly into \$BNB. Investors can directly claim there \$BNB daily or every 7 days.

☒ **1% redistribution into \$GHOST**

1% of every transaction is taken and redistributed directly to all Ghostface holders.



SO HOW DO I EARN \$BNB BY JUST HOLDING \$GHOSTFACE TOKENS?

○ This is a very unique model, which has only been done once, every time somebody buy or sells \$GHOSTFACE the \$BNB they buy/sell with a percentage (4%) is taken and held within the smart contract.

You can collect the amount of \$BNB based on the amount of \$GHOSTFACE tokens you hold. For example, if you held 1% of the \$GHOSTFACE supply you can collect 1% of the BNB reward pool.

◇ If an investor collects more than 1 \$BNB, 20% of the \$BNB will be used to buy \$GHOSTFACE on PancakeSwap and burn them immediately. This will help us reduce the supply and increase the price of \$GHOSTFACE

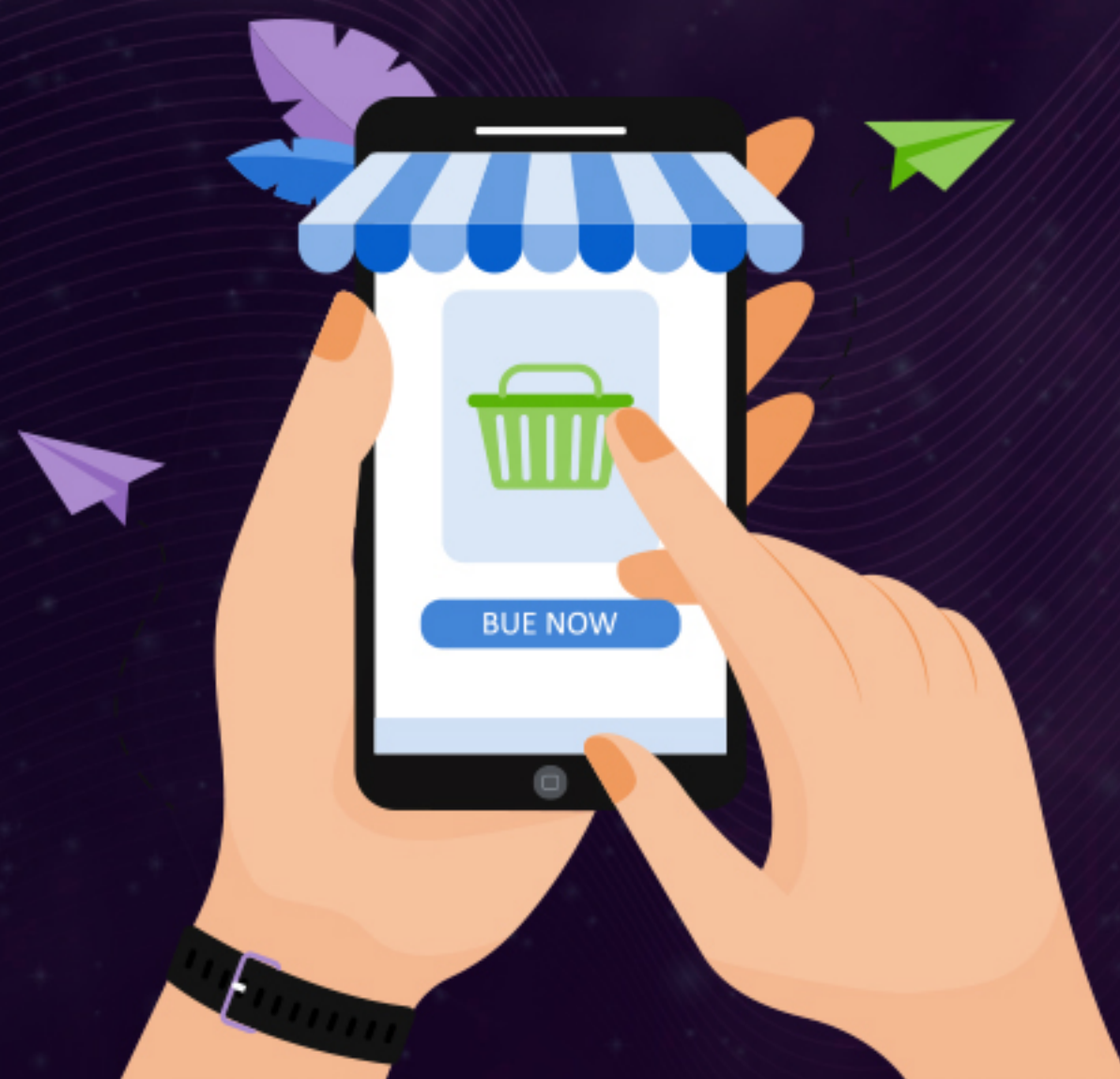
Q4 2021

Q1 2022

- GhostWALLET – iOS and Android app which will allow users to track their investments, there will be an integrated browser within the to connect to websites like PancakeSwap, UniSwap, DxSale and so on. This unique interface will allow \$GHOSTFACE holders to stack their tokens and be rewarded.
- GhostHUNT – Platform that will allow users to view new and upcoming tokens, finding out there launch date, Market Cap, and all other relevant information for the specific token. There will also be a “promoted” section, which will allow other tokens to promote a specific token onto our platform.



GHOSTSHOP

Merchandise website which allows users to purchase all \$GHOSTFACE merchandise and integrating a system to allow others to use our platform to sell their own merchandise.

Cryptocurrency Teams who will use the platform to sell their merchandise will be charged a transaction fee of 2.5% on every order. The 2.5% fee will be split 2 ways, 1.25% will go directly to Charity, 1.25% will go to the developing team.

We will be trying to integrate a Cryptocurrency payment method into the website which will allow users to connect either their Trust Wallet or Meta Mask to pay for merchandise within the website, as-well-as payment methods by Credit card, Debit card, PayPal etc:



GHOSTTRACK

GhostTRACK will be a platform, which will allow users to track their investments by linking their Trust Wallet or Meta Mask onto the platform. Individuals can enter the buy price to see a % increase/decrease of the specific token.

Investors will also be able to view the price chart of each token they're invested into. Within the platform we are integrating a system which will allow users to enter a contract address for either an ETH (Ethereum) network token, or a BSC (Binance Smart Chain) and being able to view the current information about the entered token, such as: Circulating Supply, Total Supply, Market Cap, Real-time Buy/sell orders.

Individuals will be able to enter their wallet address and receive a ranking based on the amount of \$GHOSTFACE tokens they hold.

The Ghostface team is also integrating a section on the website which will be used as ad spots called GhostLIST.



What is GhostLIST?

GhostLIST will be a section within the website where other developers of tokens, will be able to purchase Ghostface tokens then deposit those tokens into the website and being able to gain more traction/investors for their token.

What benefit do other tokens have by advertising onto the GhostTRACK website?

Token owners can get a rotation on ad spots dependant on the amount of LP tokens they deposit onto the website. There will be a minimum deposit of \$50,000, and there will be a rank system of 1-10. The ranking system will be based on the amount of Ghostface/WBNB deposited into the pool. How will Ghostface benefit from this?

Ghostface will benefit from this advertisement technique as there will be a fee structure. Ex: If "Token A" purchases \$50,000 of \$GHOSTFACE tokens there will be a upside of the current price of \$GHOSTFACE % increase, once those tokens are deposited onto the GhostTRACK website, if the depositor of "Token A" decides to remove the tokens from the website to sell, upon removal of the tokens the GhostTRACK website will charge a 20% removal fee of the tokens. The 20% fee that is kept will be burned.



GHOSTHUNT

Platform that will allow users to view new and upcoming tokens, finding out there launch date, Market-cap, and all other relevant information for the specific token. There will also be a “promoted” section, which will allow other tokens to promote a specific token onto our platform.

Option.1

There will be options for a Quick-List (12HR) which a token owner/admin will be able to use the Self-Serve option by filling out all the information about the token, uploading the contract audit and paying a \$500.00 listing fee. These listings will be prioritized over the basic service which could take up-to 3-5 business days to list on GhostHUNT. (depending on demand)

Option.2

Option 2 is a basic service, where a token/admin owner will be fill out a basic application to list, which will include detailed information about the token, total supply, pre-sale or fair launch, exchanges etc. At that point on of our team members will review the application and decide if the token should be listed onto the GhostHUNT website.

Application fees for the Quick-List or any promotions within the website would require the lister or promoter to pay with \$GHOST tokens equivalent to the \$ value.





GHOSTSNIPE

GhostSNIPE is a platform we are very excited about; it will be a website which will allow users to see up and coming tokens which are loaded with automated-bots and/or ready to buy on pancake swap. We will also have a dedicated person on the website looking for new "potential rug-pulls" We will have a WARNING section on the website which we will post about new tokens which has a large % of tokens unlocked, or LP tokens unlocked. More information about GhostSNIPE will be readily available within the coming weeks.



GHOSTWALLET

GhostWALLET will be an app readily available on the iOS & Android platform which will allow users to store all their cryptocurrencies within the app. We will be integrating a dAPP/Browser within the platform to allow users to purchase cryptocurrency which isn't readily available on Exchanges.

We will also integrate a listing platform where users can view newly listed coins and/or tokens.
