# Smart City Eco is targeting all major online global economy industries.

We want to provide smart solutions based on the blockchain technology and target the most lucrative sectors of the online economy.

Tapping into global markets and multi-trillion dollars industry, with Smart City Eco we want to create a platform that appeals to the general public and can be used on a daily basis.

A smart solution combining online economy and gaming into one smart platform. A platform that will target every day gamers and online consumers that will provide a one stop shop for all their online needs.





## Problems in the crypto world

are all around us.

We will now summarize a list of some problems we see within the crypto sphere in general.

First problem is unreliability and a deregulated market in which people with less tech sophistication tend to lose money or get scammed, people tend to have problems installing and understanding wallets and understanding crypto in general and tend to make mistakes.

One of the most common problems nowadays is the unavailability of a marketplace where people can spend their tokens.

Many projects did not offer solutions and use cases for their currency, and in our opinion, coins like Bitcoin facing their own problems with solution nowhere in sight, we offer a ready solution, which will be realized in a decentralized manner.

Also, people need to have 10 wallets and hold money on exchanges which, in our opinion, charge high fees for withdrawals, and by that, limit a regular user who has limited amount of money in each currency and could not afford to pay the 10-20 % fee.

Also there are entry fees in depositing fiat money to get Bitcoin or any other currency. People lose around 6-10 % in this situation, thus, we want to minimize that lose and offer solutions for all the cited problems above.



We plan to offer a solution for the online gaming problem seen by our development team noticing the lack of motivation for players. Now, imagine if you can play games and be rewarded for your advancements in SCE tokens where each player will be rewarded depending on their skills and progress of their online kingdom.



There too lies a problem with the security of funds, possibility of hacking and a complete loss of their funds.

Speed and transaction fees are one of the main problem of Bitcoin at the moment.

Buying of products with almost all cryptocurrency hasn't been solved yet and most of currency can be just used for trading only.

Also one of the biggest problems in fiat money economy is the unlimited printing of money which causes the currency to lose its value.

#### **PROBLEMS**



Fees for investing via credit card ranges from 6-10% using some exchanges.

Withdrawal fees from exchanges to wallet is up to 20% per token.

No reasons for tokens existence besides for trading and speculation. No solutions is provided for token spending and economy.



There is not much options open out there for hodlers of cryptocurrency to spend their money on some products and have any other benefit except saving and hoping it will rise in value.



User must use multiple wallets for holding cryptocurrency and there are a lot of unreliable solutions which do not provide a complete solution for security.

Most tokens do not provide any solution for token spending and liquidity, they may have a great product but none that will benefit the token holder since their tokens does not have liquidity and does not offer any other purpose except for trading.

Besides trading on exchanges and price speculation, our token represents the fuel for all transactions that will happen on our platform.



Our economy system will run on 10,000,000,000 tokens which are created for platform use and as long as our platform has demands, our tokens will not lose value as fiat money does thru more money being printed.

We have targeted all major sectors of online economy and we want to solve the demand problem by creating a large market and a high need and usage of our tokens and by that create a great demand for them.



Multi currency wallet that will provide safe storage of tokens and most of the more popular cryptocurrencies, 100% safe, impossible to hack and money controlled by users.

Purchasing products with SCE tokens and getting them delivered to your home address by mail. We plan to implement a lot of partner sellers that will accept SCE tokens as payments and will implement their products sales on our platform. We plan to focus on variety of products and bring in the Chinese

merchants to offer our token holders the chance to buy software goods and equipment needed for mining. Spending SCE tokens on gaming for upgrades and investing into the economy of online games offers possibility for profits, incentivizing the

boring gaming system, in contrast to the current scenario where playing online has no purpose nor reward.






