BFG ABSTRACT

One of the newest and most attentive crypto currencies, RISE OF BABY FEG, is led by a team of developers and marketing professionals aiming to create a buy-now or pay-later token. The tokenomics revolve around the fact that ROBF (RISE OF BABY FEG) will protect holders by using the buying back feature. Additionally, users can buy or sell BFG tokens and utilize them as store credit at no cost. Ideally, the team aims to create partnerships with exchanges and platforms that support the development start-up crypto currencies in the DeFi space. BFG credit will be used to make purchases at local vendors in order to expand the security of spending digital assets on a regular basis. With every buy or sell, a percentage of BFG tokens will be burned to LP in turn to increase the evaluation of the token. An integral part of this credit card is that BFG tokens will never need to be converted to fiat in order to use BFG credit as it will necessitate a direct conversion.


