

CHALLENGE



When we first started to play with our idea, the questions we asked ourselves are, what the biggest adult industry issues are at the moment. Of course, there are many, but let's focus on the most important ones.

SOCIAL MEDIA PLATFORM

Until now we haven't seen any proper social media platform in adult business that would disrupt the business. Most of adult models use Instagram or Twitter to drive traffic to their Snapchats and other adult channels where they can monetize their videos and pics. As we all know, the biggest platform that supported adult posts and articles was Tumblr. Last year, Tumblr decided to close their doors for adult industry. The only social platform that allow adult posts is Twitter, which is better than nothing. Twitter is not optimized for adult industry, so the system does not work for models in a way you would like. Adult models need to have tons of channels open, sending their fans here and there all the time. And none of those platforms are optimized for them.

Our social media platform will be ALL IN ONE, with monetizing options for models. At the end of the day, not only for adult models that work in porn. Our platform will be available for everyone to use. Basically everyone on this world will be able to monetize their talent.

PAYMENT SYSTEM

Payment system was always a big issue in adult industry. A lot of banks are closing accounts to companies that pay adult industry. With our blockchain solution, this will be thing of the past. Everyone in adult business will be able to use Vibexxx tokens to pay for goods or memberships. If they will want to withdraw into FIAT money, no problem. Just convert, and go to your ATM or do the wire transfer to your personal account. In the future, we will also offer to every adult person to use Vibexxx credit card to withdraw on the ATM's all over the world.

Last year PayPal blocked one of the most popular adult company to pay their adult models through PayPal. So you can see that payments are really an issue and we have solution for this.

CROWDFUNDING FOR MODELS & PRODUCERS

There is not known crowdfunding platform for models and producers. So why have it and why we think it would be good for the industry. Let's take few examples. Let's say a famous adult model have an idea of amazing adult video, but she don't have enough money to back it up. She opens a crowdfunding with us, announce on our social media platform or on any other channels she is using. Her fans would back her up. Everything would be controlled by smart contracts and everything would be traceable through blockchain. On the other side, adult models struggles from time to time with money issues, have bad months, maybe have health issues. So they could ask their fans to support them through their rough times. There are also producers with talent, but they don't have a backup of big companies or they can't afford to hire top adult model for their video or photoshoot. They could open a crowdfunding for their idea and people would back their unique idea and make it happen. Blockchain is perfect for backing up models and producers through smart contracts.

ADVERTISING TOOLS

There are many adult models that do not know how to advertise themselves. They are struggling and some hot adult model could give up, because he or she did not have proper support. So we will be the biggest HELP out there to them. For a small monthly fee, they will be able to use our advertising tools so they will be able to get on their feet faster.

LEARNING SCHOOL (HOW TO MAKE MONEY IN ADULT)

Another BIG, or should we say really HUGE problem for adult industry is that people do not know how to make money in adult. There are many big companies that are controlling the system. But the little adult webmasters, users and fans are also the ones who can make a big change. So with our Learning School, everyone will be able to jump on the money making wagon and grow from there. We have many connections with money making gurus, who will share their ideas and use cases. Of course, everything will be accessible for a small fee. There will be monthly fee for Learning School and anyone will be able to buy courses through our blockchain payment system with our tokens.

REWARDING SYSTEM WITH GAMIFICATION

Rewarding system will be our main thing. Users these days, loves to get something in return. Not just free porn, free adult videos or pics. They love to pay for good content, but they also like to receive rewards. New generations from X, Y and new generation Z (those who are 18+) rewarding and gamification systems are the best way to attract them to interact with the platform. Our algorithm will reward every user, every uploader, every producer, adult model for their interactions with our platform. Based on their actions, they will also receive new badges, icons and stickers, which will lead them to sort of a game. So through this gamification system, we will encourage them and engage them more.

TIPPING SYSTEM

Tipping system is not a new thing, but not many sites using this feature. Tipping is a new way of making money online. There are many talents out there, new amateur adult models who don't have any agency behind them, don't have huge contracts. So they are more or less depended on their fans. So this way, daily posts, with daily announcing what they do, naked or with clothes, showering, brushing or singing, fans will be able to tip them. The more they tip, the more they will be able to show the model on the other side. Tipping system will also be backed up blockchain and our gamification. So user and a model will grow in our rankings with badges, stickers and icons. The more you have, higher the rankings and your profile will gain on value.

LIVE STREAM - MAKE MONEY FEATURES

Live stream is nothing new in adult business. But again, there are specialized platforms where models can perform through their cams and fans are paying them for the show. So all this features and some extras will be build-in inside our social media platform. No need to go to 5 different platforms to make money. At live-stream there would be a lot of gamification involved, chat, supporting the performer and putting their tips inside their TIP-HAT. Imagine live street performer playing on the guitar and singing. He puts a hat on the floor, people are walking buy and some tip him because he is good or funny or just because they want to support the performer. The same would be here with our live streaming. Just put tips inside the performers TIP-HAT.

How the TIP-HAT will work in our live streaming option? Everyone who contributes in the performers Tip Hat, all the money that collects inside, the performer will receive 50 % from the hat and the other 50 % will be distributed to lucky 3 contributors. 1st contributor will receive 30%, 2nd contributor will receive 20% and 3rd luck contributor will receive 10% from all tokens inside the Tip Hat. Let's make an example. We have one famous model performing through our live stream. There are 500 viewers and 100 of them each gave 1\$ worth of Vibexxx tokens inside the Tip Hat. So inside the hat, we have now 100\$ worth of Vibexxx tokens. After he/she stops the performance, if he/she wants to collect what's inside the hat, he/she needs to turn it around with a click.

Our famous model will receive 50\$ worth Of Vibexxx tokens in her wallet and 50\$ will be distributed to 3 lucky contributors based on our formula above. So let's say that lucky winner #1, got 30\$ back and he gave only 1\$ into performers tip-hat. How can it get any better than that? He/she participated and watched hot model and he/she received a reward of 30\$. Well, maybe you won't win every live stream, but 1\$ is not a big loss and you helped a model make some money.

PLUG-IN FOR EVERY SITE TO INTEGRATE GAMIFICATION, TIPPING AND REWARDS

Most of our features will be able to integrate into any adult website. With our features, adult websites does not need to develop their own tools. They just connect with our API, set few things and show it on their sites. The more their visitors will interact and use our features, the more website owner will make from these features.

MARKET POTENTIAL

Market potential in adult online industry is one of the biggest of them all. More and more people are online, consuming videos and pictures all the time. Almost everyone who get online for the first time, start searching for online porn, nude women videos and pictures. There is no secret that adult online industry is shaping the internet.

Adult online business decided many times which technology will WIN and which one will lose. The biggest fight between DVD and BlueRay, adult industry dictated the path and choose DVD. At the moment VR goggles are struggling with users having them at home and play VR games and use goggles on daily basis. Again, adult industry is the leading industry that is pushing VR goggles consumption. People are hungry for VR adult videos and interactions through VR. As much as companies who owns and builds VR goggles try to distance from adult industry, they can't. At the moment 80% of VR goggle owners, are using them for watching online adult videos and play adult games.

We will not bore you with fancy graphs and numbers through the years, how much adult industry made. But we will mention just a few important numbers. Revenue in the past year is estimated between 9-15 Billion Dollars. But those who are more active in adult business, knows that it's hard to calculate the real revenue since there are many private companies, which you can't track. So some estimates this numbers goes up to 97 Billions of Dollars in 2019.


Our users at the moment we are targeting are generation X,Y and most importantly, generation Z (those who are 18+). These are the generations that will grow with the project and use it for years to come. Older generations always follow younger generation. Vibexxx users will be users who love to receive rewards, love to interact with the people on the site, they grew up with phones in their hands. They want to interact in VR world. Live streaming is something natural to them. This generation grew basically with porn in their hands. So many of them would like to follow their favourite adult model. More and more people are open to record a video, show it online and make some money.

So Vibexxx project will be focused on this user base and the rest will follow. Once they start to receive rewards, the older generation will follow. From adult models to an ordinary viewer of porn.

Our users will be ready to pay for quality porn. Our users will become loyal users, because they will receive rewards and grow in our rankings with time.

Our targeted users are also women that don't have a problem watching online porn. At the moment statistics are showing that 25-30% of adult video viewers are women. So adult online industry is becoming more and more female friendly environment. More and more companies are focusing on women. On top of that, Vibexxx project will offer them to start their own campaigns, where they can earn more rewards by posting their pictures and videos. Vibexxx will remunerate them in our native tokens. Those tokens will be convertible to other popular cryptocurrencies like BTC, ETH, BCH,... and also in FIAT money.

PLATFORM FEATURES



Our platform features will give remunerate to anyone who use our platform. From normal user to adult model to adult webmasters. Everyone will be able to get something out of our features as long as they will be interacting with our platform. So let's see what those features are:

UPLOADING VIDEOS AND PICS

By uploading videos and pics, anyone can receive rewards with us. From normal user to professional adult models and producers or even adult site owners and webmasters.

Normal users and adult webmasters - are allowed to upload videos and pics if they don't violates any video or pics licenses rules and content have visible watermark. Users who uploads the video and followed the rules, are remunerated in our tokens based on our algorithm and ads performances. Video and pics can receive millions of views, so reward can be very attractive for each uploaded video or picture. They become Vibexxx token holders ready to trade, sell or buy more tokens.

Adult models - adult models will need to verify if they want to receive higher rewards and better exposure. Every verified adult model, will receive better % from our algorithm and also Vibexxx platform will push them higher for better exposure. We will encourage verified models to posts more as this will attract more users to come back. Interaction with models is very important for returning users. Adult models also receive option to link to their other promotional channels like Twitter, Snapchats etc...

Producers and Adult Paysite Owners - Same as models, we will need to verify every producer or site owner, they will receive their own channel, where they can upload videos and pictures, with or without watermark. They also get an option to put the link to their websites with our affiliate rewards based on our algorithm and ads performance from views and shares will be added to their wallet.

LIVE STREAMING

Live stream at our Social Media platform, would be similar to other mainstream live streaming sites. The only difference would be, that we would adopt it for adult industry with features like tipping with unique "tip hat" feature, chat system, private show rooms.

At live streaming everyone would be able to receive rewards. From verified adult models, to normal users. With our live streaming option, we would attract many new amateur models that never performed before.

SHARE CONTENT & TRAFFIC PROGRAM

This feature is for everyone who uses or register at our platforms. It is very simple idea. Share our content and our algorithm will reward you based on traffic you sent to us and based on revenue made from ads. Rewards comes in Vibexxx tokens. Those are redeemable to other crypto coins or fiat money.

- Normal users and visitors - Everyone who share our content receive tokens
- Adult webmasters with adult sites - If they send traffic to our content, our algorithm will reward them with higher %, because is targeted traffic.
- Blog sites, news sites - Send traffic to our site and receive rewards.

TIP SYSTEM

Our TIP system is open to everyone who is registered with us. You can receive tips or give tips. So if you uploaded a video or interesting picture, users will be able to tip you, because they liked the content you added to our platform. With live streaming tip system is a little different. As we mentioned under challenge section, our live streaming tip system is called TIP HAT. So when a live performer starts, the "tip hat" turns around and is open to receive tips. Once the performer close the live streaming, everything inside the hat, will be distributed. 50% goes to the performer and the rest goes to lucky 3 tippers. So everyone who contribute to the streamer, have a chance to get back more than he/she put inside the hat.

LEARNING SCHOOL

Learning school is essential for Vibexxx platforms. Learning school section, will be open for everyone who would like to learn about our platform and how to make some extra rewards, or get extra exposure and promote their websites and channels. Some of the courses will be free, some will be paid. We will host some well-known names here, explaining how to make some extra reward. Learning school is something that you won't find on internet at the moment.

There is no online adult school or courses, where you can actually learn how to become an adult model or how to make money in adult online industry.

ADVERTISING AREA

Of course, as any other platform, we will sell ads spots. This is an essential thing, for an adult website. Without ads, you can't operate the costs that comes with the high traffic website. Here we will partner with 3rd party ad networks and also build-in our own direct advertising options.

DEVELOPERS AREA

Developer's area, is reserved for anyone who loves to develop, code, design and will be able to contribute to our platforms through these tools. Example: A designer will make some extra icons and stickers. He/she will be able to put in on the market and people will buy them to be unique. Performers will collect stickers, so they will be ranked higher and higher rank will give them bigger exposure. Potentially, performer will request certain stickers to be bought by a fan, so he/she will receive a new collection of stickers.

VIBEXX BUSINESS MODEL



VIBEXX is creating the social media and entertainment platform for today's generation, inspiring more culturally rewarding, trusted, and value-driven social engagement. As a social media platform, we aim to bring people and communities together, and connect them to relevant content and opportunities while enabling every single user to monetize the value of their online activity.

The fundamental principle behind the VIBEXX ecosystem is that all participants should be financially motivated to create, share, post or like online content and share value with each other. The ecosystem itself consists of users, content creators, influencers, advertisers and app developers – all connecting and transacting with each other through a network of decentralized communities.

VIBEXX main source of revenue comes from advertising, where 60% of the revenue will be used to remunerate platform users for their engagement with the platform content (liking, sharing and commenting; for such engagement they will be remunerated in VBX tokens), while the remaining 40% will fund the operational costs and future development.

To quickly establish the ecosystem during the initial stage and encourage early user adoption, VIBEXX will set a remunerate pool of VBX tokens to kick-start growth through user acquisition, while rewarding content creators and active users for their contributions. YES, VIBEXX is about to monetise all your social media activity, even “likes” and “shares” of valuable content.

VBX is a true utility token that will power VIBEXXX social media platform, grant access to powerful platforms' features and be used to reward VIBEXXX active users:

- **VIBEXXX Remuneration Account** – VIBEXXX proprietary algorithm measures and analyses user's activity, such as uploading and sharing of the content, and determines the appropriate remuneration for each contribution based on the number of views, shares and likes.
- **VBX is the only way to receive remuneration** in the VIBEXXX platform for performed services (activities) in the network.
- **VBX token enables in-app purchases**, such as virtual goods, to pay other users (such as influencers) or grant access to new apps supported by the platform.
- **VBX token powered donations**, encouraging charities to engage with platform's users to help the needy.
- **VIBEXXX Market Place and Direct Advertising**, allowing users and influencers to promote their products and bring traffic to their websites in exchange for VBX tokens.
- **Connecting influencers and advertisers** - No more agencies' cuts. VBX tokens will be held in the escrow until both parties are satisfied with their agreement and each site fulfils its obligations.

Vibexxx Tokenization and Blockchain

VIBEXXX is creating a decentralized social media platform and rewarding mechanism powered by Ethereum blockchain.

VBX will be implemented on the public Ethereum blockchain as an ERC20 token. The Ethereum blockchain is currently the industry standard for issuing custom digital assets and smart contracts. The ERC20 token interface allows for the deployment of a standard token that is compatible with the existing infrastructure of the Ethereum ecosystem, such as development tools, wallets and exchanges. The public Ethereum network will serve as the settlement layer for VBX tokens, allowing for transfers, purchases of virtual assets and reward distribution to be made directly on the blockchain. Smart contracts will automatically execute transaction payments and the distribution of rewards without the participation of a third-party intermediary.

Moreover, Vibexxx will use smart contracts, allowing advertisers to set their own requirements and preferences. Once the influencer agrees with the advertiser's offer, the terms will be written into the smart contract, which will then be sealed with a timestamp and put onto the blockchain. When it comes to payments, one of the biggest advantages of using the blockchain technology in the advertiser-influencer relationship is the ability to offer an escrow. Both the advertiser and the influencer should be motivated to successfully fulfil contract obligations by placing a deposit in VBX tokens. This deposit is released to the Advertiser (as a payment) only after the service is rendered, forcing both parties to respect their contractual obligations. The platform will encourage and reward third party developers who will deploy and promote new decentralized applications.






