What is the Music NFT?



NFT : Non-Fungible Token

A digital token that can be stored in a blockchain to record ownership of goods. Many experts predict that NFT will usher in a new era.

Music/albums/melodies/lyrics and even a single verse can all be generated in NFT version.



Music NFT contributes to build a community of musicians and fans.

Users form good relationships with their favorite artists with music NFT.

Tokenized music is convenient for supporting to the artists.

The reasons for investing in music NFTs

The size of sound sources market

The 2021 digital music market was worth at \$12.55 billion, with Apple Music occupying the second place with a 15% share. The music NFT market has considerable Potential as a blue ocean investment field.


In 2020, the size of music NFT market was at \$338 million, and in 2021, the market size Grew by 800%.

In the first quarter of 2021, the total transaction volume of the NFT market exceeded \$1.5 billion, which means more than 2627% growth compare with the previous month. The market cap of NFTs crossed the \$30 billion mark for the first time in the second quarter of 2021.


Music NFT market status

The traditional music market is completely different from the blockchain music market. The fact that the traditional music market doesn't lead to actual decentralized blockchain is close to the traditional digital music reproduction (limited to the manufacture of digital collections)

Currently, the most users are basically web2 users. The total number of web3 users are relatively small.



Step2 : Generate a musician's private Gsound



Gsound is

A sound source NFT generated by a musician's work.

How to get Gsound?

Discover excellent musicians and support their reputation and revenue generation.

When users vote and mine on Gsound, the dividends will continuously generate for the holders.

When the Gsound rank rises, the holders get rank-matching bonuses.

How do we trade Gsound?


As the Gsound holder changes, the profits are distributed to the new holder.

Trade on the homepage or NFT trading sites.

Step3 : Staking



Staking Participation

Investors use their MNOTE tokens to lock-up mining on their favorite Gsound to win the corresponding prize. This Gsound holder is also given a continuous dividends.

In case of lock-up mining, it predicts the rise and fall of ranks. If your prediction is successful, you will receive the prize. No penalty mechanism in case of failure.

*The sooner you participate in the lock-up, the higher the profit. The earlier the participation time, the higher the mining incentive allocated by the system.

MNOTE Tokens

MNOTE is the only token on the platform. Participate in Gsound trading. Participate in ranking lock-up mining.



MNOTE Tokens

More about 1-Godboard TOP100 Music exchange (lock-up)

Mechanism:

1. Investors lock-up on highly preferred Gsound.
2. The larger the lock-up quantities, the higher the Gsound rank.
3. Top 100 investors and their corresponding Gsound according to Gsound ranking. Receive additional bonuses of the prediction success rewards.
4. When Gsound enters the TOP 100, the rank goes up/down.



1. Gsound ranks : Generate revenue by lock-up rising/falling in ranks of music sources.
2. Revenue for investor = lock-up mining rewards + ranking rewards + ranking rise/fall prediction rewards
3. Holders (Musicians are original owners) = lock-up allocation + Gsound transaction
4. Lock-up timing: The sooner you participate in the lock-up, the higher dividends you will get. The later you enter in it, the lower dividends you will get. (This prevents the lock-up from being concentrated on the 5. upper class Gsound chart.)


More about 3-Mining output curve



MNOTE tokens are operated in two ways: Pre-mine & Stake rewards. Premine constitutes only 5% of the total supply and is entirely used for airdrops.


Stake rewards, MNOTE tokens can be acquired per second lockup = Amount of lockup * (lockup time / elapsed time since project since project start)

According to the theory above, the faster the lockup progresses, the higher the yield and the lower the mining amount.



As the total issuance increases, the ratio of mining output to total issuance decreases.

After a certain period of time, inflation will be fairly controlled. The users' growth will soon exceed the current rate of growth.

Smart Contract

In Smart Contract, all processes are automatically proceed as long as the contract conditions in the code are met. Because it is recorded on the blockchain, no one can change the initially stated conditions, and it implements a complex and diverse contract model according to each business logic.

6— Terminology

1 DAO- (Decentralized Autonomous Organization)

An organization (spontaneously created by a group with the same consensus) derived from the blockchain ideology. By-products of resolving the trust issues between people in the blockchain.

2 DeFi- (Decentralized Finance)

It doesn't depend on the financial institutions such as securities, exchanges and banks. Finance that works by smart contracts on the blockchain such as Ethereum.

3 NFT- (Non-Fungible Token)

Unique representation cryptocurrency tokens (including JPG and movie clip formats), it can be bought and sold.

4 Music NFT-

A fixed number of tokenized audio files with no unique ownership. The majority of today's music NFTs have exceptional digital collections. No ownership statements, no royalties/publication rights. It applies to the rare version that only represents songs or albums in web3 chain.

5 **DAO/Staking-**

Investors use their MNOTE tokens to lock-up their Gsound on the chain and receive dividends steadily. Gsounds in TOP100 will have the face value from voting with holders' MNOTE tokens.

Defi/lock-up*continuous dividends
