



Discover entrepreneurs, specialists, investors or explorers. It's extremely revolutionary to have it in one application. Create your teams for any project. It's never been easier.



#### **MOONAI MAP:**

We thought about four types of cards:

- Startup
- Services
- Associations
- Art

For each company, service, association or artist, you will have:

- A photo
- A description
- Links to:
  - Website
  - Different social networks (we will try to integrate a broadcast into all your automatic communication channels)
  - A rating by a specialist and an expert that we will choose at the outset. We will then develop a robot that will find you a specialist and an expert according to your criteria. The main factors to start with will be:
    - The place
    - The expertise you are looking for (we can call on two experts if necessary)
    - The specialty in which you plan to implement yourself (we can call on several specialists if necessary)
    - The number of ratings that experts and specialists have already made as well as the correlation with the scores of their "colleagues" (an average score will be assigned to the project)

The rate for a rating by an expert and a specialist is \$100. The idea is that you will work half a day. We will develop tools ("standards") over time to enable you, Expert or Specialist to make quick, informed decisions via very precise indicators.



#### How is it legally to make a rating?

Experts and Specialists will be self-employed or a moral company for which the Expert/Specialist is in charge. A contract will be written between us "Moonai", you "third party" as well as the Expert and Specialist. The connection fee will be 15% of the amount. For example, on \$100 Gross, \$15 Gross will go to Moonai.

For people who will be registered as an Expert or Specialist in the application without having the status of self-entrepreneur or a moral society will not be able to go further in the process. We advise you to put your SIRET number in the description to make it easier for us in our search. We will then integrate a box dedicated to the SIRET number **so that we can have direct access to your professional profile**.

The level of Experts and Specialists will be indicated with a level above or equal to the BAC. 1 for the first year after the BAC, 5 for the second year of master's, 8 for the doctorate. We will adapt our repository according to the particularities of certain countries. Nevertheless, the "LMD" system is international. You will need to provide your level and send us a proof for the color to appear. A gray round will make up your level, it will have a color if your profile has been checked. We've also thought about people who stop at a level and focus on experience, a small "O" will be added in addition to your level. For example, if you stopped at level "3" or 3 years after the IBC, and you decided to work afterwards, you'll get "3." This system will be extended.

Of course, this feature will be developed after the ICO. For now, you will be able to describe yourself, indicate your geographical presence as well as a description of yourself.

NB: If at some point you want to change your specialty, then it will be easy, we can integrate a second grey round in which you will have your level with your new specialty. The same pattern will take place.

Connecting through the app is completely free for now. We will offer you after the ICO, a guarantee of intermediation between the provider and you. We will keep the amount awarded for the duration of the benefit until 14 days after the end of the benefit to ensure that there are no holes in the racket. The issues will be arbitrated in a systemic way. We will take all the data necessary to make a fair and appropriate decision with the means we have. The retention of the amounts requires PSAN approval.

We will use Blockchain technology for payment methods.

Finally you will understand, our vision is to make Entrepreneurship, eventually, a Game !

We will develop a point system later to accompany all the ecosystem with Moonaï Awards to reward the best Investors, Entrepreneurs, Experts and Specialists by category.
