Non-Fungible tokens or NFTs for short are unique digital items that are issued on a blockchain. In many ways, they hold similar qualities to items in the real world. Think about physical goods like limited-edition trainers, collectible baseball cards, or the limited edition drops by clothing brands such as Supreme.

Unique and distinguishable

These digital items are distinguishable from one another by a unique number. That number or serial number for NFTs is a token ID, which is stored on the blockchain. The serial number works in the same way as a barcode and the code corresponds to the information about that particular item: how it looks, its distinguishing attributes, the artist or organization that made it, and more.

Contract of ownership

Ultimately NFTs can be digital collectibles, game items, but also concert tickets or perhaps a digital key that unlocks a certain door. As a result, you can look at NFTs as digital contracts of ownership. These tokens on the blockchain can prove that someone owns a certain piece of art or digital collectible, but they can also show you have lifetime tickets for the ufc

NFT marketplaces are quickly rising to prominence in 2021 and NFTs are becoming the new asset class to care about in the crypto space. NFT marketplaces, simply put, provide a marketplace for the buying, selling, and trading of NFT tokens.

What are NFTs? To explain in detail is best left to this article. In essence, an NFT is a completely unique class of tokens. Bitcoin and Ethereum are ERC-20 tokens, they are not unique as many people hold them.

By comparison, an NFT or ERC-721 token is a one-off and carries unique identifiers. In this instance it's what gives the NFT its value, like Bitcoin, its scarcity. Daps such as Cryptokitties and Crypto punks pioneered the NFT collectibles hype back in 2017 and continue to lead the space today.

Due to the fact that an NFT ERC-721 token is completely unique, some of the first alliterations to enter the market have utilized art and digital items. It's quite simple to understand why art came to the fore so quickly. After all, if Leonardo da Vinci had made 100 copies of the Mona Lisa then the original would never have been so valuable we presume

Top NFT Marketplaces for Creators to Sell Non-Fungible Tokens

NFTs are non-fungible tokens. They are unique items that you can't replace with something else. For example, a one-of-a-kind trading card is an NFT – you can't just replace it with any other card. If you trade your card for some other card, you have something different. These differ from fungible items, which are often the same as each other. If you trade one bitcoin for another, you end up in the same position as where you started, for instance. On the other hand, if you swap a near-worthless mass-produced

late 80s baseball card for a 1909 American Tobacco Company T206 Honus Wagner card (valued at over \$1 million), you've done very well for yourself.

Nowadays, most NFTs tend to be digital. This makes it particularly easy for creators to give their supporters something rare and unique. Some NFTs, for example, are digital artworks, and people are now collecting these digital artworks, just like collectors have collected physical paintings for years. And some of these NFTs have gone for extraordinary prices. One NFT artwork by a digital artist called Beeple sold for \$69 million at Christie's.

A more down-to-earth version of a modern digital NFT is CryptoKitties. They are an Ethereum blockchain game where users can buy, sell and breed digital "cats." Every "cat" is unique (just like your real-life pet).

In some ways, NFTs are similar to Bitcoins and other cryptocurrencies, except, of course, they are non-fungible and non-divisible. The first NFTs were part of the Ethereum blockchain, which stores extra electronic information to distinguish their uniqueness. Other blockchains now also facilitate NFTs. Because of the differing blockchain technology behind particular NFTs, not all NFT marketplaces buy and sell all types of NFT. Creators will often select an NFT marketplace based on whether that marketplace supports a specific NFT token standard. Ethereum has released two standards now: ERC-721 and ERC-1155. Competitor, Binance, has since released standards BEP-721 and BEP-1155. The two "1155" standards differ from the original "721" standards because they allow multiple NFTs to be bunched and transacted together.

Most NFT platforms require buyers to have a digital wallet and use cryptocurrencies to pay for their purchases.

What should I know before minting my first NFT?

Minting an NFT on the main platforms is a pretty straightforward process, especially if you're already comfortable with dApps and Web3 interfaces.

If you're new to crypto and don't know your way around MetaMask, it might be better for you to work with an agency that walks you through the process and takes care of the blockchain stuff for you.

Of course, we highly recommend getting familiar with crypto and Web3 for your own benefit. So if you feel like learning, go ahead. Not just for the sake of minting NFTs, but to open up the world of DeFi (or decentralized finance)—a rich cornucopia of tools and protocols for you to explore. Crypto has a reputation for being prohibitively technical and while that was certainly true in the early days, that's really not the case anymore if you take the time to learn and explore.

These digitally unique assets are attached to a distinct value with a certificate of authenticity, so even though it exists online, the asset can't be easily and endlessly duplicated. That's because each NFT exists on decentralized digital platforms based on blockchain technology. Transactions on a blockchain platform are written to a digital ledger. That ledger publicly records every NFT transaction to confirm the item's ownership.

Blockchain supports replicable tokens including Ethereum and other crypto currencies -- which were once viewed as unstable and confusing, but have seen a meteoric rise among those ready to embrace the digital alternatives to traditional currency.

"NFTs can't be duplicated or copied, they're verifiably scarce," said Decrypt editor-in-chief, Daniel Roberts. "All it really means is that it can't be divided, duplicated, subbed one-for-one."

NFT defined

Merriam-Webster officially defines the three letter acronym as "a unique digital identifier that cannot be copied, substituted, or subdivided, that is recorded in a blockchain, and that is used to certify authenticity and ownership of a specific digital asset (such as the original version of an online photo or video).

"When a new word makes its way into the world's lexicon, our ears at Merriam-Webster perk up," Peter Sokolowski, Merriam-Webster's editor-at-large, said when they announced the new word. "Over the past several months, NFT has rocketed into popular culture, and the team at Merriam-Webster crafted a definition to provide meaning to this emerging technology."


