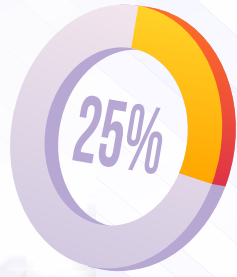

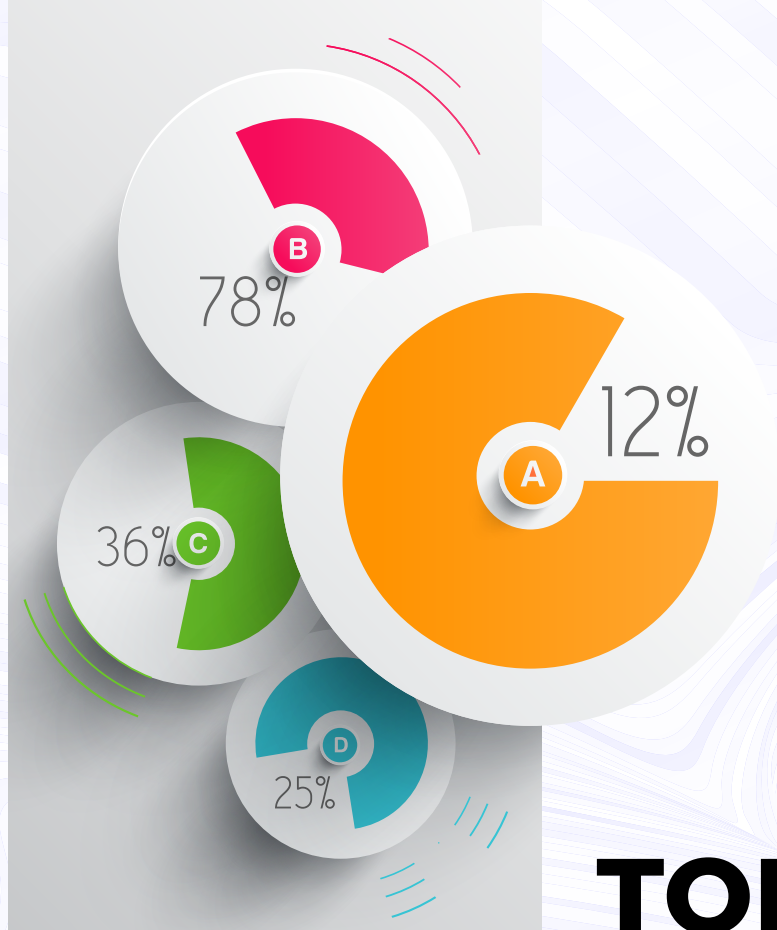
Penguin NFT Launchpad
